

2022 MEIJER LPGA CLASSIC FOR SIMPLY GIVE

Ticket Terms and Conditions

THIS TICKET MUST BE DISPLAYED AT ALL TIMES, and is a revocable license to attend the 2022 Meijer LPGA Classic ("Tournament") at the Blythefield Country Club, in Belmont, MI from June 13-19, 2022. This ticket may be revoked without refund or other consideration if the holder of this ticket ("Holder"): (a) tampers with or attempts to transfer/re-sell/re-package this ticket; (b) violates any Ladies Professional Golf Association, Inc. ("LPGA") or LPGA Tournament Properties One, LLC ("LTPO") rules/regulations, venue security restrictions, or the instructions of authorized personnel; (c) solicits contributions or distributes literature or promotions on or around the Tournament site without prior written permission from the LPGA, LTPO and, Meijer Great Lakes Limited Partnership ("Meijer") and/or Outlyr, Inc. ("Outlyr"); or (d) uses foul/abusive language or obscene gestures, or otherwise engages in inappropriate, disruptive, or illegal behavior; as determined by the LPGA, LTPO, Meijer and/or Outlyr. All items brought through the gate area into any LPGA/LTPO controlled venue are subject to reasonable inspection. Except as authorized by the LPGA, LTPO, Meijer and/or Outlyr, lawn chairs with arms, coolers, golf clubs, electronic devices, cameras (except during practice rounds), and all other irritants or distractions are strictly prohibited. No refunds, exchanges, or rainchecks will be issued. Tickets are non-refundable. Lost or stolen tickets may be replaced at the option of LPGA/LTPO/Meijer and/or Outlyr.

Holder agrees not to sell, transmit, or aid in the transmission of any account, description, picture or reproduction of the Tournament and related activities. Holder grants to LPGA/LTPO and Meijer the unrestricted and assignable right/license to utilize Holder's image or likeness incidental to any recording, transmission, or reproduction in any medium, whether now known or hereinafter devised, worldwide and in perpetuity.

Holder VOLUNTARILY ASSUMES ALL RISK AND DANGER incidental to attending the Tournament and related activities, from both known and unknown causes and both obvious and hidden conditions, including, without limitation, being struck by misdirected golf balls or carts, any injuries on the Tournament golf course and surrounding areas, and actions of third parties whether such risk or danger occurs prior to, during, or subsequent thereto, and hereby

RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE LPGA, LTPO, Meijer, Outlyr, Blythefield Country Club, Tournament partners, participating players, sponsors, volunteers, media producers and distributors, agents, licensees, and all officers, directors, employees, agents, sponsors, assigns, and affiliates thereof (collectively, "Releasees") from all liability to Holder, his/her personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of personal injury, death, or loss or damage to personal, private, or other property and equipment, whether caused by the negligent acts or omissions of the Releasees or otherwise, resulting from or arising out of Holder's attendance at the Tournament. HOLDER AGREES TO INDEMNIFY AND DEFEND AND HOLD HARMLESS THE RELEASEES from and against any and all claims, demands, actions, proceedings, lawsuits, fees, fines, penalties, liabilities, losses, damages, judgments, settlements, costs and expenses (including reasonable and actual attorney fees and all other costs of litigation, including expert witness fees) brought, imposed, or alleged by a third party against any of the Releasees due to Holder's use of the ticket, including, without limitation, acts or omissions or allegations thereof while present at or around the Tournament site. The Releasees shall not be responsible to Holder for punitive, incidental, consequential or special damages. Holder agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted in the state of Michigan, and if any portion thereof is held invalid for any reason, it is agreed that the balance shall continue in full legal force and effect. Any disputes involving the Releasees shall be resolved by arbitration in the State of Michigan pursuant to the Commercial Rules of the American Arbitration Association then in force. A judgment upon the award rendered by the arbitrator(s) shall be final and non-appealable and may be entered in any court having jurisdiction thereof. If the Holder is a parent or guardian accompanying a minor or minors to the Tournament, by allowing the minor(s) to attend the Tournament with Holder, Holder is deemed to have given all of the foregoing grants of rights, releases and waivers on behalf of such minors.

COVID-19 ASSUMPTION OF RISK/RELEASE OF LIABILITY

Holder acknowledges that COVID-19 is extremely contagious and that despite the measures the Tournament has implemented to help mitigate the risk of transmission, the elimination of risk of

exposure and infection to COVID-19 is not currently possible. By entering onto the grounds of the Tournament using this ticket, holder acknowledges and agrees to the following for holder and on behalf of any accompanying minor (who shall also be deemed to be "holder" for purposes of the following): HOLDER ASSUMES ALL RISK AND DANGER ARISING OUT OF HOLDER'S ATTENDANCE INCLUDING, WITHOUT LIMITATION, RISKS RELATED TO COVID-19, LOSS OF HOLDER'S PERSONAL PROPERTY, INJURY, OR DEATH FROM A GOLF SHOT OR BY OTHER SPECTATORS OR PLAYERS, AND HOLDER HEREBY RELEASES THE RELEASEES FROM ANY AND ALL LIABILITIES ARISING OUT OF SUCH LOSSES, INJURIES, ILLNESS OR DEATH.
